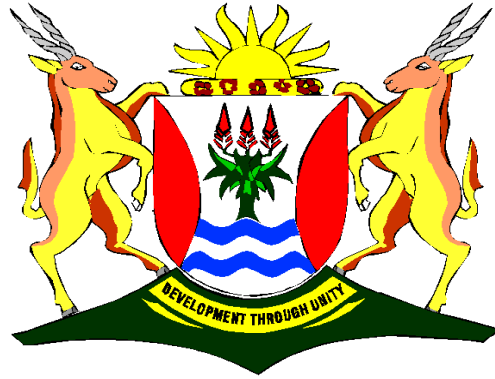

Beware of Fake Emails Impersonating ECPT Officials

The Eastern Cape Provincial Treasury warns service providers and the public about **fraudulent emails** circulating under the names of Provincial Treasury officials. These emails are **fake** and not from the Department.

- ✓ The email did **NOT** come from ECPT.
- ✓ Fraudsters used fake cellphone numbers and a fake signature.
- ✓ ECPT officials do **NOT** communicate directly with bidders outside formal SCM processes.

NOTICE TO ALL SUPPLIERS!

The Eastern Cape is currently at **80 % compliance** with the submission of **Proof of Address (PoA)** on the **Central Supplier Database (CSD)**. Suppliers were given sufficient time to upload their PoA. Several notifications were sent to suppliers to update their profiles, especially on the uploading of their POA.

Please note that National Treasury, as the **custodian of CSD**, will commence the process of de-activating **non-preferred or secondary physical addresses that do not have a valid PoA loaded onto their CSD profile**. This is the **final opportunity** for suppliers to upload their **PoA** to avoid being de-activated on the CSD.

Failure to comply will result in suppliers being unable to bid for tenders or conduct business with the State. Suppliers are therefore encouraged to **log into their CSD profiles as soon as possible**, ensure their details are up to date, and to upload a valid **PoA**.

QUICK REFERENCE USER GUIDE

CENTRALISED SUPPLIERS DATABASE (CSD) REGISTRATION

INTRODUCTION

This guide serves to assist users of the new Centralized Suppliers Database (CSD). By following the steps in this quick reference guide access to the CSD and registration of suppliers will be possible.

STEP 1

- Prospective users will have register as users on the CSD website and follow the following actions;

1. Enter www.csd.gov.za in web browser

the user is navigated to the CSD Home Page

2. Click on **Register** on the menu bar on the CSD Home Page

3. Enter your:

- E-mail address
- Name
- Surname
- Cellphone number

4. Select an identification type in the identification type dropdown

5. Enter identification number



If a foreign passport number or foreign ID number is entered then a work permit number must also be entered

6. Enter a password



A password must contain a minimum of 8 characters and include a capital letter, a lower case letter, a number

and a special character

7. Confirm password

8. Select and complete 3 security questions

9. Check the **I am not a robot** Captcha

10. Check the **I accept the terms and conditions**

11. Click on the **Register** button

- The following message will be displayed: *'Thank you for registering. An account activation e-mail has been Sent to you'.* In order for you to use your account, you will have to click the link in the

- The account then needs to be activated. Please follow the following steps;

1. Open the CSD activation e-mail and click on the **Activate Account** link



A One Time Pin (OTP) is sent as an SMS to the cellphone number provided on the registration screen

2. Enter the OTP in the Account Activation screen

3. Click on the **Submit** button

- The following message will be displayed: *Account activated.*
- The message will have a **Log In** link

STEP 2

- Once the account has been activated then suppliers can start to be captured onto the CSD.
- By going to add supplier and clicking on each tab, supplier information is captured onto the CSD by category.
- Information entered is verified automatically through National Treasury, via the CSD linkages to various organizations.
- The last tab, Overview, gives detail on the progress of the application. Use it to reference if any information has been omitted.
- Once no outstanding tasks are flagged in the Overview, the application can be submitted by clicking SUBMIT.
- The supplier number and security code will then be generated for the supplier. Both are extremely important and need to be recorded for safekeeping.
- The supplier is now registered on the CSD.

CSD- FREQUENTLY ASKED QUESTIONS AND ANSWERS

1. Supplier(s) that cannot login on CSD

Questions (What can I do)	Answers
i. I have forgotten my password.	Click on Login/Forgot Password/Put in Email Address/Select OTP SMS Option (2 nd Option) or Click on Login/Forgot Password/Put in Email Address/Select Email Option (1 st Option) an email link to reset password.
i. I have changed my cell number or I lost my phone with the number on CSD	Get an old copy of a CSD Report, the email to use is the one that says Created by on your CSD Report. Contact your nearest CSD office to check OTPs then change the number.

2. Supplier Banking Details Failed

Questions (What can I do)	Answers
Banking Details Failed i. Incorrect Company Name/Surname	When you get this error message, it means what you have Captured on CSD under Bank/Account Holder Name is not the same as what the Bank has, For Example my company is CSD TRADING (PTY) LTD and the bank has written it as such on their System but when you put it on CSD under account holder name and you just type CSD TRADING it will return the "Bank Verification Failed error message and the reason will be incorrect company name or surname. If the name of the company is, too long (e.g. MASIBAMBISANENI BAFAZI TRADING AND PROJECT PRIMARY COOPERATIVE LIMITED). There are high chances that this name will fail even if you included exactly as it is in the bank letter, so we advise Supplier to visit bank and request a screenshot of banking system to verify if how is it written in the banking system. The following are the systems used by various banks. i. FNB – HOGAN ii. NEDBANK – BANKING PLATFORM iii. ABSA – CIF SCREEN

	iv. STANDARD BANK – BANKING LOOKUP SCREEN
ii. Incorrect ID or company registration number	Supplier should ensure that their bank account is Active meaning it is not a reserved account because CSD does not verify Reserved Accounts . Supplier should ensure that the ID and the Company Registration Number is linked to the Account Number .

3. Other common CSD related questions

Questions (What can I do)	Answers
i. Suppliers in Deregistration Process.	Supplier should file his/her CIPC Returns so that the status can reflect “ In Business ”
ii. Supplier's Tax is non-compliant.	SARS Requires all companies to file their returns twice a year (by the 28 th of February and by the 31 st of August) it is the responsibility of the supplier to make sure that all their returns are up to date to avoid Non-Compliance.
iii. Supplier's Tax is non-compliant	B-BBEE expires after a year from date of issue. There are 3 types of BEEs you can get: B-BBEE certificate from SANAS accredited agency, B-BBEE certificate from CIPC, Sworn Affidavit from Commissioner of Oath
iv. Supplier's Tax is non-compliant	Supplier should ensure that all the SBD documents are signed and declare when necessary and make sure they complete the job as per the order.
